The adopter releases and waives any claims against Cobb County, which he/she may have now or in the future, for any damages to persons or property caused by the animals.

The adopter understand that the animal has not been thoroughly examined or treated by a veterinarian and has been possibly exposed to infectious diseases while at the CCAC shelter.

Therefore, the adopter agrees to take the animal to a licensed veterinarian for examination and any needed treatment in the next five (5) days.

It is understood that under no circumstances shall the CCAC shelter be obligated to pay any bills. veterinarian expenses, or other expenses incurred by the adopter.

If a licensed vet certifies, in writing, within five (5) days of the adoption that the animal is diagnosed with an infectious or life threatening disease or has died of a life infectious disease, the adopter may receive an exchange or refund.

The exchange will be valid after a mandatory three (3) week waiting period, for health and sanitation reasons, has expired. The CCAC shelter shall have the right to deny or delay any exchange if a licensed veterinarian does not confirm the diagnosis.

The medical return priviliges extend only to medical reasons unknown at time of adoption. At no time may the animal be returned for any medical reasons, which were known, and articulated, to the adopter, at the time of adoption.
